Website Visitors

Like most website operators, Centrum Evanston collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Centrum Evanston’s purpose in collecting non-personally identifying information is to better understand how Centrum Evanston’s visitors use its website. From time to time, Centrum Evanston may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

Centrum Evanston also collects potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on WordPress.com blogs. Centrum Evanston only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below, except that blog commenter IP addresses and email addresses are visible and disclosed to the administrators of the blog where the comment was left.

Gathering of Personally-Identifying Information

Certain visitors to Centrum Evanston’s websites choose to interact with Centrum Evanston in ways that require Centrum Evanston to gather personally-identifying information. The amount and type of information that Centrum Evanston gathers depends on the nature of the interaction. Those who engage in transactions with Centrum Evanston –

by contacting Centrum Evanston, for example – are asked to provide additional information, including as necessary the personal information required to handle those interactions. In each case, Centrum Evanston collects such information only insofar as is necessary or appropriate to fulfill the purpose of the visitor’s interaction with Centrum Evanston. Centrum Evanston does not disclose personally-identifying information other than as described below. And visitors can always refuse to supply personally-identifying information, with the caveat that it may prevent them from engaging in certain website-related activities.

Aggregated Statistics

Centrum Evanston may collect statistics about the behavior of visitors to its websites. Centrum Evanston may provide it to other organizations. However, Centrum Evanston does not disclose personally-identifying information other than as described below.

Protection of Certain Personally-Identifying Information

Centrum Evanston discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that (i) need to know that information in order to process it on Centrum Evanston’s behalf or to provide services available at Centrum Evanston’s website, and (ii) that have agreed not to disclose it to others. Some of those employees, contractors and affiliated organizations may be located outside of your home country; by using Centrum Evanston’s websites, you consent to the transfer of such information to them. Centrum Evanston will not rent or sell potentially personally-identifying and personally-identifying information to anyone. Other than to its employees, contractors and affiliated organizations, as described above, Centrum Evanston discloses potentially personally-identifying and personally-identifying information only in response to a subpoena, court order or other

governmental request, or when Centrum Evanston believes in good faith that disclosure is reasonably necessary to protect the property or rights of Centrum Evanston, third parties or the public at large. If you are a registered user of Centrum Evanston's website and have supplied your email address, Centrum Evanston may occasionally send you an email to tell you about new features, solicit your feedback, or just keep you up to date with what's going on with Centrum Evanston. We primarily use our various product blogs to communicate this type of information, so we expect to keep this type of email to a minimum. If you send us a request (for example via a support email or via one of our feedback mechanisms), we reserve the right to publish it in order to help us clarify or respond to your request or to help us support other users. Centrum Evanston takes all measures reasonably necessary to protect against the unauthorized access, use, alteration or destruction of potentially personally-identifying and personally-identifying information.

Cookies

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. Centrum Evanston uses cookies to help Centrum Evanston identify and track visitors, their usage of Centrum Evanston website, and their website access preferences. Centrum Evanston visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using Centrum Evanston's websites, with the drawback that certain features of Centrum Evanston's websites may not function properly without the aid of cookies.

Business Transfers

If Centrum Evanston, or substantially all of its assets, were acquired, or in the unlikely event that Centrum Evanston goes out of business or

enters bankruptcy, user information would be one of the assets that is transferred or acquired by a third party. You acknowledge that such transfers may occur, and that any acquirer of Centrum Evanston may continue to use your personal information as set forth in this policy.

Privacy Policy Changes

Although most changes are likely to be minor, Centrum Evanston may change its Privacy Policy from time to time, and in Centrum Evanston's sole discretion. Centrum Evanston encourages visitors to frequently check this page for any changes to its Privacy Policy. Your continued use of this site after any change in this Privacy Policy will constitute your acceptance of such change.
